PSC/IR 106: Introduction to International Relations

International relations is the study of how states interact with each other. This course builds a working knowledge of our field, introducing the background, theoretical, and empirical tools necessary to understand international relations today. Students will learn about important findings in a variety of subfields, including war, international political economy, institutions, and nuclear proliferation. To do so, the course emphasizes readings from original research material rather than from a textbook. Further, students will solve problem sets and work with common international relations datasets to obtain a working understanding of the discipline's methodological foundations.

Course Materials

Recitation

This class has weekly recitations in place of the scheduled Friday lecture. We will meet in class on the first Friday (9/5) to assign you to a teaching assistant. Recitations are mandatory and constitute a large portion of your grade. There will be no leniency for students attending lecture but not recitation.

Evaluation

Grades have four components: two problem sets, two data analyses, recitation, and two exams. The problem sets are worth 10% each and will test your ability to think strategically about basic problems in international relations. The two data analyses are worth 5% each and will ask you to become more familiar with IR's common datasets. Recitation is worth 20% and will be based on attendance and participation, as your teaching assistant will further detail. The exams are non-cumulative and each worth 25%.

After weighting each individual grade, final grades will be no worse than the following:
